AS LEAD HIRER I AGREE TO ABIDE BY CLEL TERMS & CONDITIONS, POOL OPERATING RULES, and take overall responsibility for all swimmers in my group. I confirm none of the swimmers in my group have any contagious diseases or medical conditions which prevent them from swimming.

I NOTE THAT ALL PEOPLE PRESENT in the Pool room must be listed on this form, (with non-swimmers annotated NS and ages given for children below 16.)

MAXIMUM no of swimmers is **8** (unless a lifeguard is present), **MINIMUM** is 2 competent people in the poolroom.

Children up to the age of 7 are not recognised as “competent in an emergency” by SWIM ENGLAND.

LONE SWIMMING or 2 SWIMMING WHERE ONE is UNDER 7 years old is only BY PRIOR ARRANGEMENT & SUBJECT TO CCTV MONITORING of the POOL ROOM

ALL SWIMMERS 16 years and OVER implicitly accept compliance with the Terms & Conditions and Rules of Hire **All children up to and including 12 year olds, MUST be supervised** in open water environments where there is a risk of drowning; groups may arrange for professional assistance/swimming instruction to comply with this condition

ACCESS to Changing room is 10minutes before and 20 minutes after slot

STRICTLY NO DIVING/RUNNING/JUMPING/BOMBING as the pool has a uniform depth of **1.3m**

All SWIM AIDS/TOYS MUST BE British Standard (BS) APPROVED, be accounted for and removed from the pool before closing the cover

NO FOOD or ALCOHOL is to be consumed on the premises, which are strictly **NO SMOKING**

ALL DISPOSABLE NAPPIES MUST BE COMPLETELY CONCEALED with a neoprene swim nappy, and **ALL WASTE NAPPIES SHOULD BE BAGGED, REMOVED FROM THE FACILITY, & IDEALLY PUT IN THE ESTATE OFFICE BIN**

To conserve heat and running costs please leave doors and windows shut and all pool room lights should be switched off and cover closed if there is no group swimming after you. For security any windows opened in the changing rooms should be left closed. Please note all changing room lights are movement sensor lights and are automatically switched on and off. CLEL accepts no liability for loss or theft from the facility.

ALL CARS MUST OBSERVE THE ESTATE SPEED LIMITS and drive with extreme caution at all times. **PARKING** is restricted to the **VISITORS** car park unless Hirers require **DISABLED** access. **NO ACCESS** is permitted to the **WIDER ESTATE** at any time unless CLEL has given **PRIOR PERMISSION**
